Holiday Skip-A-Pay is Back

Giving to a worthy cause can be a great feeling. The credit union is 049699 giving you an opportunity to contribute to such a cause and free up some money for Christmas shopping or everyday needs.

Now through December 30th, members can skip either 401884 their October, November, or December loan payment in exchange for a \$20.00 donation to the Children's Miracle Network (CMN).

Members are allowed one skipped payment for each loan per year. Loans are also subject to a maximum number of payment deferrals for the

life of the loan. Any loans that have reached either of these maximums are not eligible. Mortgage loans are also ineligible for the holiday skip-a-payment.
